Playing the game

Hesitation - note from the Directors Bidding in tempo all the time can be challenging as some hands are more difficult to bid than others. However, the longer you take to decide, the clearer it becomes to everyone, especially your partner, that you have something of interest in your hand. If, on your turn to bid, you pause for thought and then pass your hesitation has conveyed information to partner. Partner is then placed in a difficult situation and should only bid if they would have bid anyway, regardless of your hesitation. If either of your opponents has any reason for concern they should seek agreement that a hesitation has occurred and reserve their rights until the conclusion of the hand. If, after playing the hand and checking the score, an opponent believes that they were disadvantaged by the hesitation they should call the Director for a ruling.
